From the District Rep.'s Desk

“Mail Count Disrupted: What Happens Next?”

The 2018 national mail count was quite an experience to say the least. We had nearly 1500 routes counted between the CT Valley and Greater Boston Districts. Not only did we have to deal with inclement weather once during the 12-day mail count, but we were hit with two major storms. The first week of the mail count, many offices experienced tremendous winds and flooding which caused widespread power outages. This occurred at the end of week 1. The timing of this storm caused some issues, delays with mail processing and delivery, but most would sustain to normal by the end of the mail count and the mail should have caught up with the delays by its end a week later.

But wait, there's more...

5 days after the major storm, we were hit with a Nor'easter that would cause even further disruptions. Some who had just regained electrical power were hit again. Mail flow was disrupted due to major high-ways being impassible. This occurred with only two days left of the 12-day mail count period. Though these severe weather disruptions and delays impact mail counts, all is not lost. We have a nationally agreed upon contingency plan when severe weather impacts a mail count. Below is a portion of the language contained in the contingency plan:

2018 National Rural Route Mail Count Contingency Plans

“Contingencies should only be implemented in those instances when there is disruption of service and an office receives little or no mail for delivery due to severe weather or other conditions. District personnel should discuss each situation as it occurs with the National Rural Letter Carriers' Association district representative and make a determination as to the validity of the disruption and the resolution for completion of the mail count. Should weather conditions cause the suspension of service for longer than three days, management and union representatives at the national level will make a determination as to the appropriate resolution. The parties at the local level may not agree to extend the mail count beyond the March 9, 2018 end date.”

Throughout the mail count and after, there has been much discussion between myself and Operations Programs Support with both districts to determine where and if adjustments are needed to the mail count due to the weather disruptions. We will not only be looking at the mail volume totals (letters and flats) but we will be determining all aspects of mail count credits. Parcels, loading times, col 17 times etc.

We have heard from many of you either via telephone calls, emails, mail count dispute forms or other means etc.

We know where the offices are that were impacted, and I have very high hopes to come to resolutions for those routes that sustained these impacts and adjust where appropriate. Again, dialogue has been very positive with both districts and I expect to come to agreements with them so that no route has an impact that is storm related.

We do have a couple of other issues that came up prior to and during the mail count, and those will be addressed on a case specific basis through the normal dispute process.

I would like to mention how very pleased I am with the attendance at our mail count schools that we conducted. We had tremendous turnouts. In looking at the signup sheets for these meetings, 500 carriers attended. They came to learn and hopefully the trainings were of benefit to them. There are so many rules surrounding a mail count. We have many newly appointed regular carriers and many seasoned carriers that have not been counted in quite some time. I truly feel that the best way to educate yourself is by attending the mail count schools. There, specific questions are answered, and we are made aware more thoroughly of some of the issues that offices are facing. I must thank Assistant District Representatives, Bill Smith and Joan Tenerella. They were both a tremendous help in making the mail count schools a success.

If you submitted a mail count disagreement. It should have been provided to your postmaster and a copy sent to me. I will be meeting with the districts to resolve as many of the disagreements as possible. You should receive a written response from management regarding your disagreement.

Once the written response is received and if we determine that there is a violation of the mail count rules, the grievance process in some cases would be the next course of action.

Hello Everyone!

I hope you all survived the winter storms, mail count, Christmas chaos and everything else over the seasons. I know mail is high and parcel volume is high and the weather has not been to cooperative, but I trust we all are doing the very best we can to do our jobs safely and accurately and going home in the same manner as we came into work which is the number one priority. We have our Spring State Meeting coming up on May 6th, 2018 and I encourage you all to come. We always have such great and informative meetings. I always learn new things at each meeting I attend. Even if you think it will be the same information you already know, whether you heard it at your district meeting, read it in the Back-Roads Journal, read it in our National Magazine or our State or National website, I assure you there will be something new. People ask different questions that require answers you may not have known! We also have lots of fun at the meetings, raising money for PAC by having raffle tickets and raffles, or silent auctions, or little contests.

This year at the May State Meeting we will be giving away gift cards for the raffles. Gift cards are for Amazon and we have 3 prizes. One for \$200, one for \$100, and \$50 cash. The Senate passed their 2018 budget resolution on October 19th last year. “The House taking up and passing the Senate’s version of the 2018 budget resolution is a short victory for postal and federal employees,” says our National Board Member Paul Swartz with Governmental Affairs in our National Magazine *the National Rural Letter Carrier*. The 2018 budget resolution directs the House Oversight and Government Reform to come up with \$32 billion in deficit reduction proposals over the course of ten years. While the Senate’s version does not include any cuts to postal and federal employee benefits, does not mean they won’t try. That is why calling or writing to your local congressperson is so important. They do indeed take the time to listen to the people,

we are the people and our voices matter!

We are always battling congress with budget cuts, reduction of mail delivery, service standards and more. Congress is releasing a 2019 budget proposal when they are still working the kinks out of our 2018 one. We’re sure we will be facing postal and federal employee benefit reduction proposals in this new budget as well. That is why PAC is so important, because we stand up and fight those cuts! Like the last proposal called for USPS to reduce delivery days from 6 to 5 and changing door to door delivery to curbside and cluster boxes.

Massachusetts is doing well this fiscal year with PAC’s fundraising. We only have about three months left of this fiscal year. So far, we have raised \$2,681.99! These numbers do not include the spring district meetings yet either because it takes a little bit for National to process everything that comes in. I am hopeful we can surpass last years total. To do so we need to step up together! Donate for a worthy cause, get involved with your union, and most importantly vote and mail your ballots back in! I thank you all for your time, demanding work, and generosity to this union and to PAC as well.


