Don served as a member of the National Legislative Committee, Steward Task Force One and on the National Resolutions Committee as a member and Chair. His route is a K45 non-L in Malibu Canyon California, serving 453 mounted boxes and is 57 miles long. His route receives both DPS letters and DPS flats and is assigned an LLV. Don is happily married to his lovely rural carrier wife Michelle and has two grown daughters, Samantha and Taylor.

Report of the Vice-President

Spring is here and warmer weather is on it's way. District meetings are completed and the Spring state meeting is next. This year our spring state meeting will be held on Sunday, May 5, 2019 at the John Carver Inn & Spa in Plymouth. The room rate is \$161. You'll need to mention that you are with the Marlca to receive this rate. The Marlca board has decided to pay for the entire lunch and you will *not* be charged \$10.

Our national officer this year is NRLCA Vice President Don Maston. This is his first year as Vice President, he previously served as an NRLCA executive committeeman. It would be great to see a large turnout at our state meeting to show Don that Massachusetts rural carriers care about their jobs and we have concerns when it comes to the USPS. Carrying mail in the north-east is different than other parts of the country. Besides having the heaviest mail volume in the country, many of you still have amazon to contend with. Our voices need to be heard!

RSD is back and every route has to be mapped. This is one of the requirements for RREC's our new evaluated system. Take your time when mapping and be precise. There is no definitive date to when RREC's will go into effect but your edit books and 4003's need to be accurate. There are many changes coming our way and questions need to be answered. You can ask the national officer these questions at the Spring state meeting.

Legislative issues have been the same for the past few years. Every year we lobby for these issues and are promised full support from our states representatives and senators. This year besides having two new state representatives, the presidents task force has released its findings. The USPS is going to be under attack! The job we perform everyday could possibly change if the report findings are put into place. Now more than ever we need to educate ourselves on these issues and prepare ourselves for a battle. We need to write or call our senators and representatives and let them know that this is not acceptable and we expect them to fight for their constituents. No excuses!

Attendance has been declining at both the state and district meetings over the past few years. Board members are carpooling to district meetings to save on mileage costs. Districts have their meetings in locations that don't require a rental fee. The only cost we can't control is the price of food. Most venues require us to give a guaranteed count for food. The best we can do is estimate how many members we think will attend. The State has already taken some cost saving measures by reducing our guaranteed food total and switching to a half day format for our fall booster meeting. We are continuing to look for the best venues in the state. District food totals vary between \$300 & \$700 depending on their size. After attending five district meetings this past month and meeting approximately 90 carriers I was very disheartened. We have over 1300 members and only 90 attended their meeting. This equates to 7% of our membership. I understand members may have other obligations but I learn something new at every meeting. The total cost to conduct a district meeting averages between \$500 & \$1000 Including printing, postage, & door prizes. I believe it's time to take another look at our districts and realign if need be.

Springtime also means election time. When you receive your ballot please take the time to vote. The State officer and Delegate for national convention are two separate elections held at the same time. The members running for these positions have your best interest in mind and are willing to sacrifice their time to benefit you please vote. See you in May!

Update on Rural Route Evaluated Compensation System (RRECS)

Since the June 23rd, 2018 final report of the engineering panel for the Rural Route Evaluated Compensation System (RRECS), the postal service has had teams developing the software and systems to support RRECS. As we move forward with implementing RRECS, the USPS is conducting an end to end test on 4,205 rural study routes to confirm functionality of the system.

A critical component of testing the functionality of internal systems necessary for the implementation of RRECS is Rural Street Database (RSD) mapping and certification. In order for a route to be certified, all key mapping components must be entered in the RSD software system. Some of those being mail box location, location where the vehicle stops to affect delivery to the mailbox, where the vehicle parks to deliver a parcel etc....

Entered. Once all is complete Lines of travel (PS Form 4003) as ASM data from your edit book. mounts and distances are also without any errors, they system

will "certify" the route in RSD. The postal service was to begin recertification of the original study routes on February 8, 2019. Again, this current testing will only involve the original routes that were previously mapped in RSD. Of the 4,205 study routes, there are 67 routes in the CT Valley District that will be re-certified. There are also 52 routes that will undergo this recertification process in the Greater Boston District. **No changes will be made to a route's evaluation from this re-certification process.** Again, this process is only to test the functionality of the system. All carriers involved with any part of RSD should be compensated for all time associated with the process.

There will be two actions required that will be completed prior to the recertification process:

Each postal area was required to send their rural analyst or designee to an RSD refresher training in Memphis, TN on January 15-16, 2019. This was a train the trainer session as was done in the initial roll-out. The areas were then responsible for training the districts. I was allowed to attend the training as an observer with the Northeast Area managers that was conducted over a period of two days (January 23-24, 2019). The districts were then responsible to train the individual units on mapping and recertification of the study routes. April 1, 2019 is the expected competition date for study routes to be recertified in RSD.

Second, HQ Rural Delivery has identified critical steps that must be completed prior to the carrier going into RSD to recertify

their route. Completing these items drastically reduces the time to map the route in RSD.

These critical actions that needed to be completed no later than February 1, 2019 on the study routes within each area are:

1. Complete/update edit books
2. Confirm accuracy of PS 4003 line of travel (Carrier must follow established LOT)
3. Complete/update dismount worksheets in RWHT (Address locations match AMS)
4. Confirm all study routes have the "Rural Study Software" on their scanners

These tasks were to be completed by February 6, 2019;

A mandatory stand-up talk should have been given to the 4,205 rural routes carriers that are involved in the RRECS study. As part of the RRECS study, specific software was downloaded to the carrier MDDs (scanners) giving access to additional required daily scans. These scans were included as part of the previous National mail count and is imperative that these scans be completed daily as they occur.

The stand-up talk details the required scans as part of the RRECS study as well as maintaining edit books and 4003's.

Keep in mind this is a test for the functionality of the system. The NRLCA will be involved in final mapping and decisions on the RRECS. The mapping process for the re-certification process should be much easier than the original roll out. Most of the study routes were previously certified and for most will not see many changes when mapping this time occurs unless there have been route adjustments etc. since the original mapping.

I must again stress that all of this current process is only a test. No route evaluation will be changed because of this exercise or the data collected. The USPS is just testing their own internal systems to determine if they can meet the requirements placed upon them by the engineering panel.

Although the panel has completed their report regarding time standards, there are still a few items regarding time standards that need to be negotiated between the parties prior to any implantation of the RRECS. Most data are collected through current internal systems. For example, end of run reports, MDD technology etc.... but there are some items that are not captured through automated data collection and it may be necessary to conduct some type of "mini-mail count" to capture raw letters and flats etc.... Further details will be on the national website NRLCA.org as the information becomes available.

Notice of Proposed MaRLCA Constitution Changes (for discussion and vote on May 5, 2019)

The first 5 proposed constitution changes pertain to election procedures and were submitted by the Election Committee Chair, Gil Perez.

#1

(b)Article: V Sec 3 B

PRESENT LANGUAGE:

Nominations for candidates for MARLCA offices will be officially open with the call to order of the MARLCA semiannual meeting in November, and shall be closed forty (40) calendar days prior to the opening session of the MARLCA annual convention. The district association secretary of each district will notify the MARLCA Secretary/Treasurer in writing of all candidates nominated for the MARLCA office at the meeting. A member may be nominated for the MARLCA office upon timely receipt of a letter to the MARLCA Secretary/Treasurer, signed by the member nominated.

PROPOSED LANGUAGE:

..., and shall be closed fifty (50) calendar days prior to the opening session of the MARLCA annual convention...

#2

(b)Article: V Sec 3 C

PRESENT LANGUAGE:

Nominations for candidates for MARLCA offices and National Delegates shall be in the office of the MARLCA Secretary/Treasurer at least forty (40) calendar days prior to the MARLCA annual meeting.

PROPOSED LANGUAGE:

...at least fifty (50) calendar days prior to the MARLCA annual meeting.

#3

(b)Article: V Sec 3 E

PRESENT LANGUAGE:

... Said ballot will be mailed to all members eligible to vote, at their last known home address, at least twenty (20) calendar days prior to the opening of the MARLCA annual meeting....

PROPOSED LANGUAGE:

... Said ballot will be mailed to all members eligible to vote, at their last known home address, at least twenty-five (25) calendar days prior to the opening of the MARLCA annual meeting....

#4

(b)Article: V Sec 3 F

PRESENT LANGUAGE:

Each member will be provided a plain envelope marked "BALLOT" in which to seal his/her ballot for mailing to the address designated by the Chairman of the Elections Committee. This sealed envelope will be placed in another envelope also marked "BALLOT" and supplied by the MARLCA Secretary/Treasurer on which the member's name, address, and local unit will be clearly marked for official identification.

PROPOSED LANGUAGE:

The state Board may authorize reimbursement of up to One Hundred Twenty-Five (\$125.00) for hotel expenses. Any reimbursement in excess of the \$125.00 will require two-thirds of the members attending a state meeting to authorize a pay revision for delegates attending a specific National Convention.
