## From The District Rep's Desk

### Art Courcy, CT Valley/ Greater Boston DR



We all are certainly experiencing unprecedented times with the recent outbreak of the coronavirus COVID-19.

Our NRLCA National Officers have been closely following the quickly developing news about COVID-19's spread for several weeks, and are continuing to gather information from the CDC, WHO, state and local public health departments, and other government and health organizations about recommended actions to prevent the spread. As a result of these recommendations, the NRLCA National Board has determined staff, representatives, and meetings to the greatest

that it is in the best interest of our members to limit non-essential travel extent possible.

Many of us are within the very serious reactions to the such individuals, including fam-

groups that are at an elevated risk for virus or are in frequent contact with ily members. We are also frequently

in close contact with members of the public. Thus, like many businesses, unions, educational institutions, and other organizations across the country that have canceled meetings and events and limited travel, we have decided to follow the best public health practices and cancel events that involve large gatherings of people. This will help to diminish disease transmission and protect everyone in our communities, particularly the most vulnerable.

Also, in an effort to keep our stewards protected as best as possible, we will be limiting some of the meetings that we have always attended for the time being. We will however, continue to participate in meetings pertaining to grievances, pre-disciplinary interviews when requested by the carrier and all other aspects of union representation related to our duty of fair representation.

The USPS has issued an updated version of its COVID-19 supervisor and management guide;

**CORONAVIRUS DISEASE 2019 (COVID-19) UPDATED SUPERVISOR AND MANAGEMENT GUIDANCE (V.2)**  
**March 13, 2020**

The Postal Service continues to monitor the spread of COVID-19 across the United States. The following information is provided to assist you as managers and supervisors to communicate with your employees.

**Key Facts to Emphasize:**

- 1) While there is still much to learn about the unfolding situation involving the spread of Coronavirus Disease 2019 (COVID-19), the immediate health risk from COVID-19 is considered low for the general American public
- 2) If you have employees exhibiting these symptoms: fever, cough, and shortness of breath, provide them with a surgical mask and require them to go home and seek medical attention. Then, inform the District Occupational Health Nurse Administrator (OHNA) immediately
- 3) The best preventive strategies against COVID-19 to communicate to your staff are:
  - Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing.
  - Avoid touching your eyes, nose, and mouth with unwashed hands.
  - Avoid being exposed through close contact with people who are sick.
  - Stay home when you are sick.

**General Guidelines:**

- Immediately Report any communication you receive from the Public Health Office or Centers for Disease Control and Prevention (CDC) concerning an employee's health to your District HR Manager and District OHNA. Your HR Manager and OHNA will provide you with instructions for future action.
- If an employee in your facility has contracted COVID-19 or has been directly exposed to someone with COVID-19, the Postal Service will follow Public Health Guidance. Your HR Manager and District OHNA will provide instructions for future action in this situation.
- Prior to an employee returning to work after visiting any country identified by the CDC as a level-3 country (currently China, South

Korea, Iran, Italy, and most other European nations) within the past 14 days or from a trip on a cruise ship in which an identified case of COVID-19 was detected on board the ship: o If employees under your authority meet the above criteria, you must immediately inform your District Human Resources (HR) Manager and the District OHNA.

o Employees who meet the above criteria must not report to work for a period of 14 days from the date they departed from any of the listed four countries, certain European nations, or the cruise ship with reported COVID-19 cases.

o Employees instructed to stay at home after visiting any one of the four listed countries, certain European countries, or cruise ship will be provided TACS Code 086, Other Paid Leave, to cover the employee's absences under these circumstances for a period of up to 14 days.

o Employees who are asymptomatic but who develop COVID-19-related symptoms while at home during the 14-day period will be charged sick or annual leave after the first 14 days.

- An FMLA packet should be generated for any employee who uses leave in conjunction with COVID-19.
- Allow liberal sick leave usage for employees who are sick.
- Ensure approved hand sanitizer (containing at least 60% alcohol) is available at work.
- Ensure CDC posters concerning COVID-19 are posted in appropriate locations.
- Deliver stand-up talks regarding COVID-19 in a timely manner.
- Provide the contact information of your District OHNA and District HR Manager (list attached) to all employees under your supervision.
- Provide surgical masks to any employee who requests one, which can be ordered through eBay Plus.
- Ensure Postal facility is cleaned daily as per the MMO-031-20, Influenza and Coronavirus Cleaning Contingency.
- Only advise other employees, if asked, that an employee has been "cleared" to return to work

### DO NOT:

- Ask employees to stay at home without HR review.
- Request medical documentation for employees to return to work unless they are on sick leave pursuant to Employee and Labor Relations Manual (ELM), Section 513.
- Request fitness-for-duty evaluations for employees to return to work.
- Share specific health information about any employee, including an employee who is suspected or who has been confirmed to have COVID-19.
- Make "medical decisions."

### On the Contractual Issues news front;

The NRLCA was notified by USPS HQ that a new scan has been established for parcels that have been attempted and the customer has requested redelivery. At this time, this has been established as a carrier scan. When a customer requests redelivery of a parcel, the clerk is to pull the parcel and hand off to the carrier informing them of the redelivery request. Prior to loading, the carrier is to enter the "Out for Redelivery" scan of the parcel.

For now, rural carriers should record these additional scans (18 seconds each) in the comments section of the 4240 and will compensated for the scans accumulated via 8127 time. IF a route is required to perform an inordinate number of these scans that might affect the evaluation, a grievance should be filed requesting a base-hour change to the route. We expect the number of these scans to be insignificant but we will evaluate on a case-by-case basis. The requirement for carriers to make this scan will possibly be short-lived as it was suggested to USPS Operations to just have the clerk make this scan before handing the parcel to the carrier.

#### Where are our retroactive payments from our latest national agreement?

##### Step 4 Grievance Filed on Delayed Retro Payments

On February 21, 2020, the Postal Service notified the NRLCA that the contractual retro payment would be delayed once again due to programming issues within the system. This delay would cause the retro payment to be processed and paid on May 15, 2020. The National Agreement was ratified on August 6, 2019. This latest delay would cause rural carriers to wait some forty weeks before receiving the retro payment. This delay is inexcusable, excessive, unreasonable, and unprecedented. Rural carriers have been harmed by being deprived of these required retro payments. The Postal Service has unjustly enjoyed an interest windfall as rural carriers have waited patiently and had to forgo or delay financial decisions, losing out on the opportunity to accrue interest and realize other gains through their TSP contributions and other investments. The Postal Service has not kept its contractual promise and we intend to enforce the National Agreement at Step 4 or in National Arbitration
